BOUL SUES THE STATE OF WASHINGTON FOR SYSTEMIC SEXUAL ABUSE IN JUVENILE DETENTION CENTERS ON BEHALF OF 188 VICTIMS

New Sexual Assault Abuse practice area established to seek justice for survivors of abuse

On September 5, 2024, Bergman Oslund Udo Little filed a lawsuit against the State of Washington and several of its agencies alleging the widespread and systemic sexual and physical abuse of 188 minors within state-operated juvenile detention facilities.

The lawsuit against the Department of Children, Youth, and Families, Department of Social and Health Services, Juvenile Rehabilitation Administration and other state agencies details a harrowing pattern of sexual abuse by guards, counselors, teachers, and medical professionals as well as instances in which staff allowed other inmates to sexually assault victims.

The abuses, which date back to the 1960s, occurred at Echo Glen Children's Center, Green Hill School,

Naselle Youth Camp, Maple Lane School, and several more. The plaintiffs, who were as young as eight at the time, were placed in these facilities as wards of the state.

The lawsuit alleges that these agencies failed to safeguard these children even though they were aware of the ongoing abuse. Instead, it contends that they fostered a culture of fear, violence, and cover-ups, prioritizing the protection of the state from liability over the safety and well-being of the children in their care.

"The scale and duration of the abuse detailed in this complaint are heartbreaking," said Vanessa Firnhaber Oslund, BOUL attorney representing the plaintiffs. "The State of Washington had a legal and moral duty to protect these vulnerable children. Instead, these kids were subjected to depraved sexual abuse at the hands of those who were supposed to care for them and rehabilitate them."

FIRM CREATES A NEW SEXUAL ABUSE PRACTICE AREA

The lawsuit against the State of Washington and several of its agencies is the first for BOUL's new sexual abuse practice area and will be led by partner Vanessa Firnhaber Oslund and attorney Ruby Aliment. The sexual abuse practice area will focus on seeking justice on behalf of survivors of institutional childhood abuse.

Oslund is a supportive and fearless advocate of sexual abuse survivors who understands the devastating effects of sexual abuse. She has nearly two decades of experience seeking justice on behalf of her clients against large corporations and institutions, and recently lobbied Washington lawmakers to allow juvenile sexual assault survivors to pursue civil claims regardless of how long ago the abuse occurred.

Aliment has been standing up to large corporations, government entities, and insurance companies since 2016. She has a proven track record advocating for and empowering sexual abuse survivors and has volunteered with the Seattle Clemency Project. Prior to becoming an attorney, she worked with sexual assault survivors on college campuses.

Vanessa's path to becoming a trial lawyer was far from easy. When she joined BOUL in 2008, her potential



as a trial attorney was not immediately recognized. Even after securing a plaintiff's verdict in 2011 as a second chair, it took several more years before she solidified her place at the lead counsel's table. Despite facing doubts and being advised by some to stay back and handle briefing work, Vanessa forged ahead, carving out her own unique approach to trial advocacy. Her determination and refusal to conform to the conventional mold of a trial lawyer have been key to her success.

This award also acknowledges a lawyer's ability to train and elevate others, a responsibility Vanessa embraces wholeheartedly. She actively encourages younger attorneys to take on significant responsibilities during trials. For example, last year, she stepped back into a second-chair role, supporting a less experienced colleague who was taking lead in her first trial. Vanessa's support and guidance was instrumental in achieving a medical malpractice verdict of over \$13 million with her colleague, Ruby Aliment.

Vanessa's leadership is defined by her collaborative spirit and trust in her team. She does not impose her methods on others, recognizing that there is no single right way to try a case. Her approach challenges stereotypes within the courtroom and reflects the values of equality and justice she fights for on behalf of her clients.

Vanessa's victories in the courtroom are matched by her passion for representing asbestos victims and survivors of childhood sexual abuse. She has represented hundreds of mesothelioma victims and their families for more than a decade, achieving many multimillion-dollar settlements and verdicts. She currently

represents hundreds of clients who were sexually abused as children in state-run detention facilities and leads the firm's new Sexual Abuse practice area.

Recognition as the Tom Chambers Trial Lawyer of the Year is a testament to Vanessa's skill, resilience, and unwavering dedication to justice. COURT OF APPEALS UPHOLDS \$5.75 MILLION JUDGEMENT AGAINST VOLKSWAGEN IN THE MESOTHELIOMA DEATH OF SPOKANE MAN

On September 16, 2024, the Washington Court of Appeals upheld a \$5.75 million judgement against Volkswagen AG of Germany and its American subsidiary Volkswagen Group of America for exposing Thomas Sorrentino to carcinogenic asbestos through his work as an auto mechanic at United Volkswagen in Spokane, Wash. Sorrentino died of mesothelioma in February 2021, just a few days after he gave his deposition for the case.

In its ruling, the Appeals Court denied Volkswagen's motion to overturn the jury's judgment as a matter of law (JMOL). The court also found substantial evidence suggesting that Sorrentino would have heeded a warning if one had been provided and that evidence showed that Volkswagen's brakes were unsafe beyond what an ordinary consumer would expect, particularly given the severity of mesothelioma as a risk.

Finally, it was concluded that Sorrentino's claims arose from VWAG's contacts with Washington and that exercising jurisdiction aligned with traditional

notions of fair play and substantial justice. In doing so, the Court of Appeals acknowledged Volkswagen Germany's extensive ties to Washington including advertising, the creation of an extensive dealership network, and creation of service bulletins.

"The Appeal Courts decision is an affirmation that courts are an equalizing force between corporations and humans," said BOUL attorney Erica Bergmann. "Volkswagen threw immense resources trying to deny justice to Mr. Sorrentino and his family but that did not make them right or credible.

"I'm thrilled for our clients," Bergmann added. "It can be nerve wracking to wait years for judgements to work their way through the appeals process. Nothing is certain which is why we handle our trials and appeals with attention and care."

SPOTLIGHT ON KAREN BARGELT: A DEDICATED PARALEGAL AT BOUL
